2. The Context

Equal access to education for students belonging to different economic and community backgrounds have been the objective of the college. After the admission conscious efforts are taken to execute a seamless integration of these students into the main stream student body. It is ensured that there is equity in terms of opportunities provided to all the students. The institution has introduced a wide range of schemes like fee concession, fee payment in instalments, scholarships, mid-day meals, bridge course classes, special classes, remedial classes etc. to affect the inclusion of such students bring about effective inclusion. Progression of these students is tracked periodically in order to devise timely intervention.
