St. Xavier's College Simdega, At: Samtoli, Dist. Simdega, State Jharkhand, for Academic, Cultural, Sports, Extra Curricular Exchange Program, Skill Development, Out Come Based Training, Placement & related services between the two institutions.

Whereas a need has been felt for both the colleges to develop closer ties by utilizing each other's expertise and forge stronger synergies and collaborative links in furtherance of their common objectives for overall academic collaboration between the two colleges.

Now this MEMORANDOM OF UNDERSTANDING witnessth and is agreed by and between both the colleges hereto as follows: -

- 1. Both the colleges have necessary permission from the concerned authority regarding the MoU.
- 2. That for the aforementioned purpose both the colleges have agreed to exchange in the fields like academic exchange (including joint classes held for the students of both the colleges, by the faculties of different departments).
- Cultural exchange like commemoration of birth anniversaries of renowned personalities, observance of different international/ national days, celebration of local festivals, inter-college cultural competitions etc. May be organised jointly.
- 4. NSS Activities: Both the colleges can share a few programmes of NSS activities as per the convenience and feasibility.

Library facilities: Resource of both the colleges can be shared, which will be settled jointly by the library department of the colleges.

- 6. It is agreed by both the colleges that the expenses to be incurred in connection with the different programmes will be borne by the respective college of the participants/ candidates.
- 7. Both the colleges agreed that if additional assistance is required in that events Principal of both the colleges will settle mutually after discussion.
- 8. If any dispute arises in respect of MoU in that case principal of both the colleges will discuss and settle the matter amicably.
- 9. Both of the colleges has entered into the Memorandum of Understanding for the period of three years in the first phase.
